

# Sonshine Specialized Camping Ministries

## SKI BOAT/EQUIPMENT REGULATIONS (For Groups bringing their own ski boats and/or equipment)

- One individual will be designated as the "Ski Boat/Equipment Operator" for the week.
- The ski boat / equipment operator will be solely accountable for the safety of the students and equipment.
- Sponsoring organization warrants that the ski boat/equipment operator is mature, responsible, and experienced for using a recreational ski boat and/or equipment in the context of a camp setting.
- The ski boat operator will use owner's/group's bumpers and tie lines.
- The ski boat operator will idle within 400 feet of all houseboats used by Sonshine Ministries.
- The ski boat/equipment operator is responsible for transporting the ski boat and/or equipment to new areas when the house boat moves.
- The ski boat/equipment operator is under the authority of Sonshine's volunteer staff and must abide by the suggestions, guidelines, and decisions issued by the Sonshine staff.
- The ski boat/equipment operator assumes all liability for damage caused to or by the ski boat and/or equipment.
- Sonshine Ministries assumes no liability for the ski boat and/or equipment.
- The ski boat operator acknowledges that Sonshine Ministries views the ski boat and/or equipment as potentially dangerous to a camp setting. Sonshine has granted owner/operator special permission to use the ski boat and/or equipment for their personal use because the owner/operator pledges a commitment to abide by the strictest standards and safety of California Boating Law. The ski boat and/or equipment is not part of Sonshine's camping program.
- The sponsoring organization will provide liability insurance in the amount of \$1,000,000 per incident and \$3,000,000 per all combined incidents for the ski boat.
- Because the ski boat and/or is not a part of Sonshine's program, Sonshine needs signed, written, verification from each camper's parent or guardian that the camper has permission to ride in, be pulled by, or play on this additional recreational equipment. By signing below parent/guardian grants their child permission to ride in, ski behind, or play on a boat and/or equipment not affiliated with our camping program.
- Sonshine assumes no responsibility in notifying parents that their students will be using equipment not normally used in our program and not operated by our staff.
- The leadership of the sponsoring church assumes full responsibility for clearly communicating to parents that the sponsoring organization is supplying additional equipment which is not part of Sonshine's program and all benefits, routine inspections, and safety controls which come from that program.

We agree to abide by these guidelines and we hold harmless Sonshine Specialized Camping Ministries, Inc. for any loss, damage, injury sustained by the undersigned by acts of the sponsoring organization's staff and volunteers in regard to the additional ski boat and/or equipment the sponsoring organization is adding to S.S.C.M.'s program.
